Thanks to All award winners and all who participated in a wonderfully displayed show. Thanks to ALL.

We are poised to enter the Red Tier of Covid-19 restrictions and as such our capacity will increase to

39.015. visitors at one time. We will continue to adhere to the Guidelines and have a possible Gallery Reception on April 18th to celebrate our 2021 Member's Show event. Please remember that Take-in is April 5th and Early Take-in on Saturday and Sunday is available.

Occasionally, at Take-ins, Members ask, "why do we place the burden on the artist to pay the Sales Tax", and "why don't we sell jewelry, and have a "show case" of some type". Because, "it seems nothing happens." Members wonder if they are being heard. Yes, you are. These and other items are discussed at our Board Meetings and the discussion is lively, on both sides. The Board decided to keep the Sales Tax collection the way it is for two reasons: difficulty of cash control at the desk and collection errors that we actually experienced in the past even with charts at the desk. We had to make up the difference. It was advised as a solution that artists mark-up your Sales Price by a percentage to cover the "loss". As far as the display case is concerned, as stated in our By-Laws, we are a Fine Arts organization, and the Board voted to keep it that way. They like the more open, Gallery feeling, and so voted against a display case. The shrink-wrap displays are being re-organized as they were thought to be over-done.

We are looking forward to the Annual Membership Show. Our Judge is Chuck McPherson, a widely known, respected artist and prior judge and "Demo" presenter at

our Gallery. Since we will be farther along in our COVID-19 wind-down we expect a wonderful array of art and participation. Best to you all in the coming weeks, and throughout the year.

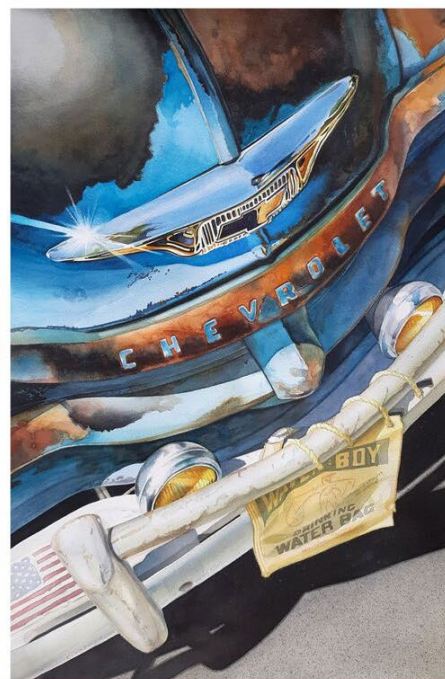
Chuck McPherson - "Fine Artist and Creative Mentor"
